Those candidates who are interested to take advantage of Tuition Fee Waiver scheme are required to apply in prescribed format available in Admission Office.

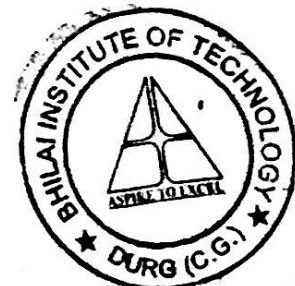
*Students admitted against JEE Quota/Management Quota are not eligible for the above scheme.*
